This boarding agreement is made and entered into between Carla Ladd DBA Ladd K9 and the person identified as the Owner below. This agreement applies to all visits by your dog to Ladd K9.

Payment

Owner agrees to pay all fees for boarding, veterinary care or other services owed on the day of pick up.

Cancellation

If you need to cancel your reservation, please do so at least 2 days before your arrival date. Ladd K9 reserves the right to charge a late cancellation fee.

Health and Vaccinations

Owner represents to Ladd K9 that to Owners knowledge, dog has not been exposed to any contagious diseases withing a thirty day period prior to check in.

Ladd K9 reserves the right to refuse to accept any dog at check in if it appears to the staff at Ladd K9 that the dog is sick, injured, in pain or that the dog's behavior could jeopardize the health or safety of other dogs or our staff.

Owner acknowledges that dog is current on all required vaccinations, flea treatment and deworming protocol as advised by owners veterinarian. Owner agrees to provide documentation as requested by Ladd K9 and shall provide proof of vaccination before entry into Ladd K9 facilities.

Owner understands that it is still possible for dog to become ill, even if vaccinated, and agrees to not hold Ladd K9 responsible if your dog becomes ill during or after his/her stay.

If at any time your dog is found to have fleas, ticks or worms Ladd K9 may provide the appropriate treatment, and Owner authorizes Ladd K9 to provide such services at your additional expense.

Emergency Medical Treatment

Owner acknowledges that in the unlikely event your dog becomes ill or injured, or your dog has a pre-existing condition which is aggravated by it's stay and requires professional attention, we will attempt to notify you or your emergency contact at the phone numbers you provide. If we are unable to reach you or your emergency contact, owner authorizes us to act on your behalf in the best interest of your dog at your additional expense.

Abandonment

Owner understands that if his or her dog is not picked up and charges paid for in full within 15 calendar days after the communicated pick up date, or owner refuses to pay agreed upon charges, the dog will be deemed abandoned and will become property of Ladd K9.
